NOTICE OF RACE

The notation '[DP]' denotes a rule for which the penalty for a breach of that rule is at the discretion of the protest committee.

The notation '[NP]' in a rule means that a boat may not protest another boat for breaking that rule. This changes RRS 60.1(a).

1. ORGANIZING AUTHORITY

The Global MBA Trophy Regatta 2022 is organized by Yacht Club of Greece / Y.C.G. in conjunction with the Hellenic Platu 25 class association (the "Organisers") under the auspices of the London Business School Alumni Sailing Club (the "ASC").

2. RULES

- 2.1. The regatta will be governed by the 'rules' as defined in The Racing Rules of Sailing (RRS 2021-2024).
- 2.2. The Platu 25 Class Rules.
- 2.3. National authority prescriptions shall not apply.
- 2.4. The use of Personal Flotation Devices is mandatory for all competitors while afloat (this changes RRS 40).
- 2.5. Rule changes will appear in full in the sailing instructions.
- 2.6. English is the official language of the event.
- 2.7. **Covid-19 Protocols**
 - a) Protocols and prescription regarding the COVID-19 may be published at any time. They will state if they have the status of a rule.
 - b) All regatta participants are required to make themselves aware of all protocols regarding COVID 19 set forth by the Greek Government, Sports Authorities and / or the Organizing authority and must comply with those prescriptions at all times during the regatta. These prescriptions or links to them will be published on the regatta website.
 - c) All regatta participants are responsible for understanding and complying with any and all travel restrictions that are relevant to travel to and/or from the regatta.



- d) [DP] Competitors and support persons shall comply with any reasonable request from an event official. Failure to comply may be misconduct.
- e) Reasonable actions by event officials to implement COVID-19 guidance, protocols, or legislation, even if they later prove to have been unnecessary, are not improper actions or omissions.
- f) The organizing authority may postpone or cancel the event at any time if it considers that this is required by reasons related to COVID-19. The competitors are not entitled to claim any compensation for any expenses they have incurred for their participation or preparation for participation in the event.

2.8. AMENDMENTS to the NoR

The Organizing Authority reserves the right to amend this Notice of Race. Amendments will be published on the Official Notice Board

3. SAILING INSTRUCTIONS

The sailing instructions will be available on or before 10:00 hrs. on 7 April 2021 at the online official notice board.

4. COMMUNICATION

- 4.1. The online official notice board is located at <https://ycg.gr/global-mba-trophy-regatta-2022/>
- 4.2. On the water, the race committee will make courtesy broadcasts to competitors on VHF radio. The channel will be stated in the SIs.
- 4.3. [DP] While, except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

5. ELIGIBILITY AND ENTRY

- 5.1. The event is open to all boats of the Platu 25 class ("A Division") and cruising boats between 35ft and 55ft ("B Division"). class(es) that are supplied by the ASC.
- 5.2. Boats may enter the event by registering online at <https://gmt2022.eventbrite.com> by 20 March 2022
- 5.3. To be considered an entry in the event, a boat shall complete all registration requirements and pay all fees.
- 5.4. Late entries will be accepted under the following conditions: At the discretion of the ASC
- 5.5. A Division
 - (a) A minimum number of 6 entries of teams are required for the A division regatta



- (b) Entries are limited to 10 teams. Boats will be allocated in a first come – first serve basis, with a maximum of one team representing each school for entries before 15 February 2022.

5.6. B Division

- (a) A minimum number of 3 entries of teams are required for the B division Regatta.
- (b) Entries are limited to 8 teams. Boats will be allocated in a first come – first serve basis.

- 5.7. The skipper or the person in charge of each competing boat (team) shall complete, representing all his crew members, the online registration form, which is available at the official notice board, not later than 20:00 hrs on 11 March 2022

6. FEES

- 6.1. Entry fees including mooring, accommodation for Division A crews, and breakfasts and social functions for all crews are as follows:

Class	Early Entry Fee until 31 January 2022	Standard Fee
A Division boats with 5 crew members or less	€2,625	€2,925
A Division boats with 6 crew members	€2,975	€3,275
B Division boats	€4,200	€4,600

- 6.2. Other fees:

- (a) A Division practice day: €250 by arrangement
- (b) B Division additional crew €350 where possible, by arrangement
- (c) B Division professional first mate €300 by arrangement

- 6.3. Fees payment

The fees listed may be paid by bank transfer. Details will be provided by email to participants

7. CREW LIMITATIONS

- 7.1. Division A

- (a) Teams applying for the A division regatta should comprise 4 to 6 competitors.
- (b) Each team needs to have at least one sailor holding a skipper's certificate (of any level and any nationality).



- (c) At least 3 crew members must either hold, or be studying for, a Masters or higher-level qualification (eg. MBA, MSc, PhD) from the Business School being represented.
- (d) Any crew members who do not qualify under 4.9.e above, must be World Sailing Category 1 (Sailing as a recreation only).

7.2. Division B

- (a) Teams applying to sail in the B Division Regatta should comprise 4 to 8 competitors.
- (b) Each team needs to have at least one sailor holding a skipper's certificate (of any level and any nationality). If no such sailor is available, the team may pay to have a qualified sailor provided by the ASC.
- (c) At least 5 crew members must either hold, or be studying for, a Masters or higher-level qualification (eg. MBA, MSc, PhD) from the Business School being represented.
- (d) A qualified skipper will be provided by the ASC. This is in addition to the qualified sailor described in 4.10.d

8. ADVERTISING

Boats shall display advertising chosen and supplied by the organizing authority

9. SCHEDULE

9.1. Registration:

The registration will take place on Thursday 7th of April 2022, from 10:00 until 17:00

9.2. Briefing

A Briefing for skippers will take place at 0900 on Friday 8th April

9.3. Dates of racing

9.4. Number of races:

Class	Number	Races per day Scheduled	Races per day Maximum
A Division	6	3	3
B Division	6	3	3

9.5. The Race Committee may adjust the racing schedule to suit weather conditions.



- 9.6. The scheduled time of the warning signal for the first race each day is:
- (a) Friday 8th April: 12:00
 - (b) Saturday 9th April: 11:00
- 9.7. On the last scheduled day of racing no warning signal will be made after 15:30.

10. CHARTER BOATS

- 10.1. The Hellenic Platu 25 association will provide the charter boats for A Division. The ASC will provide the charter boats for B Division. Boats will be allocated randomly by the organizing committee and ASC to individual teams.
- 10.2. A Division Charter boats will be available at the Yacht Club of Greece facilities in Mikrolimano from the morning of 7 April 2022 and must be returned on 9 April 2022 after racing unless otherwise arranged with the organizing authority. The boats will be available at the Yacht Club of Greece. B Division Charter boats will be made available at another marina nearby to be confirmed on 7 April 2022, at a time to be confirmed and have to be returned on 10 April 2022 at a time also to be confirmed.
- 10.3. Competitors shall not modify the boats or cause them to be modified in any way except that
- (a) A compass or GPS may be tied or taped to the hull or spars;
 - (b) Wind indicators, including yarn or thread, may be tied or taped anywhere on the boat;
 - (c) Boats may be cleaned, but only with water;
 - (d) Adhesive tape may be used anywhere above the water line with the exception of silver tape; and
 - (e) All fittings or equipment designed to be adjusted may be adjusted, provided that class rules are complied with. In particular, rig settings (shroud and forestay tensions, mast foot) may not be adjusted.
- 10.4. A Division teams may supply and use their own spinnaker sail, provided that it shows the logo of the business school or sailing club being represented. Sails shall comply with the measurement rules of the Hellenic Platu 25 class association.
- 10.5. Charter boats will be complete and ready to sail.
- 10.6. For A Division boats, in addition to the Entry Fee, a damage deposit of € 500 per boat will be charged in cash at registration and refunded at the end of the championship provided the boat is in good condition. Should the organizing committee decide to deduct from the damage deposit for any incident occurred (as per the Appendix attached to the SIs), it may require that the deposit be restored to its original amount before the team is permitted to use the boat again. Any remaining deposit will be refunded at the end of the championship. Each skipper is responsible for the damage or loss to their boat unless responsibility is otherwise assigned by the Jury.

- 10.7. For B Division boats, in addition to the Entry Fee, a damage deposit (depending on the charter company) per boat may be charged in cash or by credit card on handover of the boat and refunded at the end of the championship provided the boat is in good condition. Each skipper is responsible for the damage or loss to their boat.

11. VENUE

The shore venue will be the Yacht Club of Greece facilities and the races will be sailed at Phaleron bay.

12. COURSES

The courses to be sailed will be as follows for both A Division and B Division:

- (a) Windward / Leeward and/or
- (b) Triangular and/or
- (c) Short coastal

13. PENALTY SYSTEM

The penalty system will be defined in the SIs.

14. SCORING

- 14.1. The scoring system shall be as described in Appendix A, (Low point system) .
- 14.2. One race is required to be completed to constitute a series.
- 14.3. When fewer than 5 races have been completed, a boat's series score will be the total of her race scores.
- 14.4. When 5 or more races have been completed, a boat's series score will be the total of her race scores excluding her worst score.
- 14.5. For A Division, no time correction handicapping will apply
- 14.6. For B Division, a time handicapping system may apply.

15. BERTHING

[DP] Boats shall be kept in their assigned places while in the harbour.

16. HAUL-OUT RESTRICTIONS

[DP] Keelboats shall not be hauled out during the event except with and according to the terms of prior written permission of the race committee.

17. DIVING EQUIPMENT AND PLASTIC POOLS

- 17.1. Underwater breathing apparatus and plastic pools or their equivalent shall not be used around keelboats between the preparatory signal of the first race and the end of the event.
- 17.2. Keelboats shall not be cleaned below the waterline by any means between the preparatory signal of the first race and the end of the event.



18. RISK STATEMENT

RRS 3 states: 'The responsibility for a boat's decision to participate in a race or to continue to race is hers alone.' By participating in this event each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks. These risks include strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship by other boats, loss of balance on an unstable platform and fatigue resulting in increased risk of injury. Inherent in the sport of sailing is the risk of permanent, catastrophic injury or death by drowning, trauma, hypothermia or other causes

19. DISCLAIMER OF LIABILITY

- 1.1. All competitors (skippers and crew members) participating in the «**GLOBAL MBA TROPHY REGATTA 2022**» admit that the Regatta is and themselves are governed by the World Sailing Racing Rules of Sailing (RRS 2021-2024), the Sailing Instructions and the Notice of Race as defined in art. 2 of this NoR. Specific attention is drawn to RRS Fundamental Rule 3 and to WS Offshore Special Regulation 1.02.1 which states «*The safety of a yacht and her crew is the sole and inescapable responsibility of the Person in Charge*».
- 19.1. By filing the Entry Form in accordance with art. 5 of this NoR, participants admit explicitly that they participate and race at their own risk and responsibility.
- 19.2. All participants agree that they assume full responsibility for any possible damage (positive, negative or moral), injury and / or death of a person, participant or third party that may occur during the race or at any other time in relation to it, including explicitly from the new Coronavirus infection and COVID 19 disease, relieving the Y.C.G., The Hellenic Platu 25 class association and the "ASC", the Organizing Committee, the Race Committee, the Protest Committee, the Technical Committee, the CMO, the sponsor(s) and any other in any capacity and fully agree that they are responsible for the conduct of their crew, their representatives and their guests.
- 19.3. The Organizers, the "ASC", the Organizing Committee, the Race Committee, the Protest Committee, the Technical Committee, the CMO, the Sponsor(s) and any other person involved in the organization of the «**GLOBAL MBA TROPHY REGATTA 2022**» in any capacity, cannot be held responsible for physical or material damage (positive, negative or moral), injury and / or death of a person, participant or third party, which may occur during the race or at any other time in relation thereto.
- 19.4. It is the obligation and the sole responsibility of the skipper and all the persons handling the boat to decide on the sufficient degree of knowledge and experience of the crew, as well as the sufficiency of such crew in number, for the purposes of the absolute safe handling of the boat they sail in, the soundness and seaworthiness of the boat, with regards to wind strength and sea state as well as the weather forecast and to decide whether they will

participate or not in the event or in a scheduled race of it. They also reassure that all safety equipment is adequately maintained, and the crew knows where it is kept and how to use it.

- 19.5. The Sponsor(s) of the «**CLOBAL MBA TROPHY REGATTA 2020**» is/are released from any liability in case of accident, terrorist attack, destruction of venues used for the Event and in general events and occurrences that may cause damages to the participants, the boats and /or the venues used.

20. PRIZES

- 20.1. Prize to the winner, 2nd and 3rd place in each Division
20.2. The Global MBA Trophy will be awarded to the winner of A

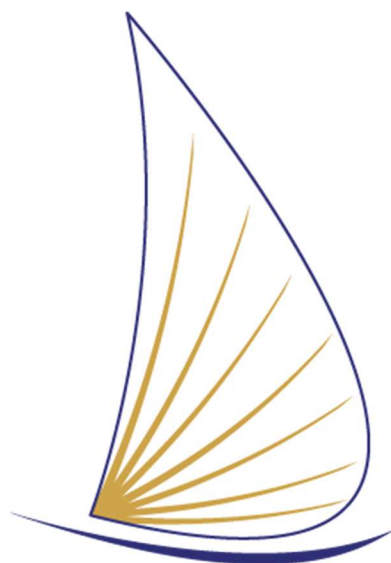
